

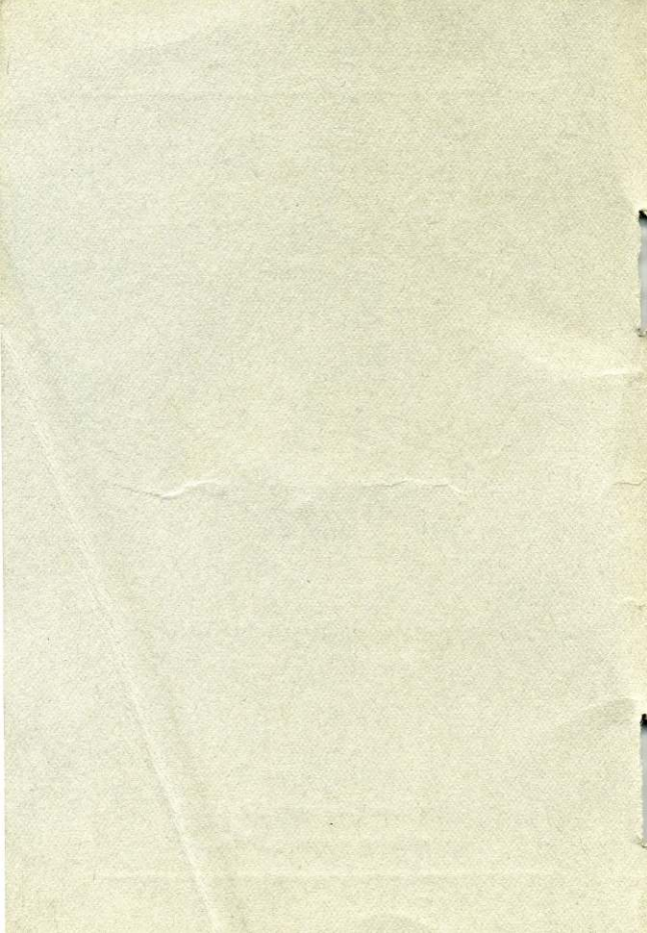

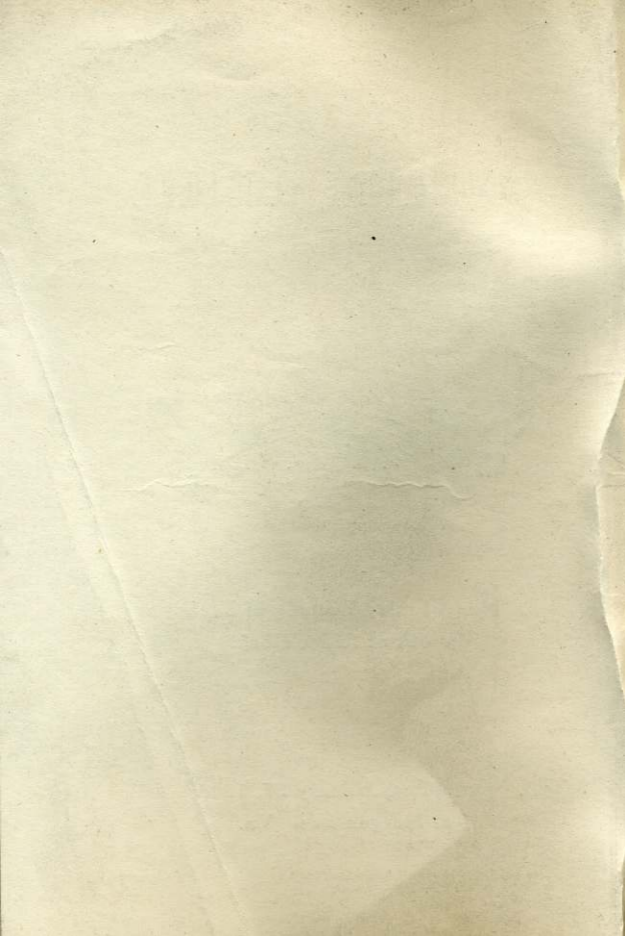

## HISTORIC MORGANTOWN.

Morgantown, built upon the site of Zackwell Morgan's settlement of 1766 or 1767 and upon land surveyed in 1781 and patented on April 7, 1784, received its earliest impetus to growth from a boat yard opened in 1772, the erection of Fort Morgan in 1772, the opening of a store by William Laidley in 1783, and the establishment of Zackwell Morgan's house as a county seat of Monongalia County in 1783, and the erection of a plain court house in 1784. It was surveyed and plotted in 1783-84 and some of its earliest lots had already been sold when George Washington called Zackwell Morgan for a conference at Pierponts one night in September, 1784. Among its prominent early visitors was Bishop Asbury who preached at Morgantown in 1785, 1786, 1788, 1790, 1792 and 1796.

Morgantown was first incorporated as a town in 1785, and it became the seat of a post office in 1794, a year before the death of Morgan. It can refer with pride to its pioneer heroes and to a long line of local leaders of achievement who guided its destiny both through its long period of slow development and its later and shorter period of rapid growth. Its earliest industries after the boatyard were a tanyard and a pottery, and later a wagon shop. Its first

local newspaper appeared in 1803. Although long isolated from the older settlements of the east, it had a vital relation to the important events on the upper Ohio. Its earliest settlers, forming part of the rear guard of the Revolution, were prominent in the advance guard of the Republic. Later, its citizens were active in movements for internal improvements and encouragement of new industries and for civic improvement and education.

In the exciting period of the Civil War, the town furnished a large and prominent leadership for the integrity of the Union, and for the creation of the new state of West Virginia. After the close of the war, and after obtaining the location of the State University, it also gradually developed a spirit of adventure in business which in 1886 resulted in the opening of railway communication—the beginning of an awakening which made modern Morgantown an educational and industrial center with rapidly increasing population, improved municipal institutions and commercial facilities, better homes and larger public spirit.

Among the recent concrete expressions of the new life are the new post office, opened in 1914, the new high school, occupied in September, 1915, the large increase in the coal industry since 1916, the expansion of the business of banks and building and loan associations, the new paving projects of

1922-23, the completion of the new Metropolitan theatre building in 1924, the construction of the large University building for Chemistry in 1923-25, the new University stadium in 1924-25, the erection of a large modern fireproof hotel and a City Hall in 1925, present plans for more adequate school buildings and grounds, and promises of a new railway station and new concrete bridges across Deckers Creek.

## ODDFELLOWSHIP OF MORGANTOWN.

Thursday, January 27, 1848, Monongalia Lodge No. 62 was instituted in Morgantown, meeting in the Hall of Masonic Lodge No. 93 and by authority of a Dispensation granted by Edmond C. Robinson, Most Worthy Grand Master of the Grand Lodge of the Independent Order of Odd Fellows, of the State of Virginia, upon application of P. R. Mitchell, John Beck, L. B. Dunlap, J. U. Beall of Morgantown, and E. L. Staley of Clarksburg.

Lodge opened in form, with A. C. Levith, Noble Grand, E. L. Staley, Vice Grand, T. L. Moore, Secretary, E. M. Davidson, S. W., A. A. Lewis I. S. G., and Cyrus Vance O. S. G., all of Adelpia Lodge No. 47, of Clarksburg. Mitchell, Dunlap, Beck and Beall were admitted as Brothers. Mitchell then presented the following applications: Geo. L. Ray, Richard B. Carr, Wm. E. Grove, William Haymond, John L. Evans, Wm. L. Evans, Thomas Evans and Watson Carr, who were balloted upon, elected and initiated the same evening. A second meeting was held at 10 a. m. the following day when the above candidates were given further degree work. At 2 p. m. the following officers were elected: P. R. Mitchell, N. G., Thomas Evans, V. G., John Beck, Rec. Secy., R. B. Carr, Cor. Secy., Geo. L. Ray, Tr., and Rev. Dunlap, Chap.



At 7 p. m. that evening the above officers were in their chairs, and the following committee was appointed to apply for a charter: Watson Carr, Wm. Haymond, John Beck, Geo. L. Ray and R. B. Carr. The first Constitution and By-Laws governing No. 62 were those used by Adelpia Lodge No. 47, which were adopted at this meeting. The next meeting was held Monday evening, March 20, after receiving the various documents.

The first Trustees of the Lodge were, Wm. Haymond, Watson Carr, P. R. Mitchell, Wm. Durbin, G. S. Ray, and C. B. Tucker. The first report of the Secretary showed 19 initiated and 3 admitted by card; second report Sept. 28, showed 7 more initiated. Geo. L. Ray was second Noble Grand and Thos. Evans third. On November 15, '48, the first fine was imposed for non attendance of 6¼ cents, similar fines were numerous thereafter. Nov. 22 Bro. ——— was summoned to appear before the Lodge and answer a charge of conduct unbecoming an Odd Fellow. Nov. 29 a \$1.00 fine was imposed and paid. Friday January 5, 1849, was the first meeting in a new hall (Chadwick Bldg.) and P. R. Mitchell was first Steward to keep up good fires on Mondays, Wednesdays and Saturdays in addition to other duties at 50 cents per week, and to make a reasonable deduction when fires are no longer needed in hall. Rent on this Hall was \$50 per year.

Saturday, January 27, 1849, a resolution was passed that any brother being found guilty of spitting upon the carpet or stove shall be fined for each offense in the sum of 6¼ cents. The first appearance of Odd Fellows in regalia upon the streets of Morgantown was a Day of Procession Sept. 6, 1849. The first death in the Lodge was Wm. Haymond Jr., who was elected Noble Grand on July 7, 1849, and died on July 13, before being installed. The principal chairs of the Lodge were clothed in mourning for 30 days in addition to the badge of mourning being worn by all members. Benefits were \$5.00 and funeral expenses were \$16.94.

By-Laws were amended, Aug. 18, to read any brother neglecting or refusing to wait upon the sick after being notified by proper officer shall be fined \$1 unless excused by a vote of the Lodge. Sept. 1, On the death of any married Brother in indigent circumstances, in good standing in this Lodge, every Brother shall be taxed by the Secretary \$1, the whole amount to be paid to the widow.

On Nov| 24, '49, a communication was received from another Lodge asking relief from this Lodge in the purchase of a certain Book published by said Lodge to prevent the Hall of said Lodge being sold by the Sheriff. 50 copies were purchased.

Nov. 25, '50, a committee was appointed to procure straw to lay upon the floor for

the better protection of the carpet. July 20, '50, motion was made to increase the pay of the Steward from 25 to 37½ cents per week. Motion lost and the Steward resigned. At this meeting there were 29 members present.

The Rebekah Degree was given on April 24, 1852, to the following: Bros. Odbert, F. J. Fleming, Watson Carr, D. R. Hoxie, Elijah Morgan, John Beck, James Nimon, Guseman and Chalfont. On May 4, '52, to Barrickman, McGeorge, Mrs. Elizabeth E. Beck, Mrs. Margaret Nimon, and Mrs. Maria G. Carr, and on May 8, '52, to Manliff Hayes, John Carney and Leroy K. Hall.

Manliff Hayes was admitted on April 19, 1848, and received the White, Covenant and Royal Blue Degrees on that date. He received the 4th or Remembrance Degree and 5th or Scarlet Degree on December 8, 1849.

Geo. C. Sturgiss made application on Saturday evening, February 10, 1866 while the Lodge was yet known as No. 62. He received the first or White Degree on March 3, 1866, after our Lodge became known as No. 10. He received the 5th or Scarlet Degree on Nov. 3, '66, elected Vice Grand on December 29, '66, and Noble Grand June 29, 1867. He was again Noble Grand in July, 1875, when No. 10 then had a membership of 75.

The White, Blue and Scarlet were the three original Degrees brought from Eng-

land to America. In 1820 the Covenant and Remembrance Degrees were added in America and taken back to England in 1826. During the time of the five degrees all business was transacted in the Initiatory Degree, and No. 62 charged a fee of \$5.—\$5.—\$4.—\$3.—\$2.—and \$1. respectively. On and after July 1, 1882, there were but three degrees, and all business of a Subordinate Lodge, thereafter, shall be transacted in the Third Degree.

The Golden Rule Degree was first conferred in America February 22, 1821. The Royal Purple Degree was added to American Oddfellowship on April 25, 1826, and the Patriarchal Degree was brought to America within the next few months. The Encampment was recognized as a special organization on May 15, 1827. Orphan's Friend Encampment No. 23 of Morgantown, Virginia, was organized in 1850.

In 1825 there were 4 Grand Lodges under the jurisdiction of the U. S., and 9 Subordinate Lodges with a total membership less than 500.

**BY LAWS**  
of  
**MONONGALIA LODGE NO. 10, I. O. O. F.**  
Morgantown, W. Va.

**ARTICLE I.**

**Name and Time of Meeting.**

Section 1. This Lodge shall be known by the name and title of "Monongalia Lodge No. 10, Independent Order of Odd Fellows of West Virginia."

Section 2. All regular or stated meetings shall be held in the Lodge Room in Morgantown, West Virginia, on Friday evening of each week at half past seven o'clock.

**ARTICLE II.**

**Executive Officers' Duties.**

Section 1. The elective officers shall perform such duties as are prescribed in the constitution for the government of Subordinate Lodges working under the jurisdiction of the Grand Lodge of West Virginia, and the charges of that office and the general laws of the order.

**ARTICLE III.**

**Special Duties of the Secretary.**

Section 1. In addition to the general duties of the Secretary, he shall on or about the end of each quarter render a statement showing the balance due to or from each

member of this Lodge. He shall further make a list and read the names of all members who are more than thirteen (13) weeks in arrears for dues, calling special attention to those who are more than nine (9) months in arrears for dues; such list of names to be read in open Lodge on the last meeting night of each quarter.

Section 2. He shall as compensation for said services receive the sum of four hundred eighty (\$480.00) dollars per annum, said salary to be paid monthly.

Section 3. He shall attend all call meetings of the Lodge and all Committee meetings when his presence and services are required, and perform such other duties appertaining to his office as the Lodge may direct, without additional expense to the Lodge.

#### **ARTICLE IV.**

##### **Treasurer.**

Section 1. The Treasurer shall receive for his services the sum of five and 20-100 (\$5.20) dollars per annum, payable on the last meeting night of December.

#### **ARTICLE V.**

##### **Duties of the Steward.**

Section 1. The Steward shall be elected by ballot at the regular semi-annual elections.

Section 2. He shall attend all meetings of the Lodge, keep the room, anterooms, halls, stairways, kitchen, dining-room, furniture regalia, and emblems in proper order.

Section 3. He shall receive for his services such compensation as the Lodge may from time to time allow, and shall be paid on the last night of each month or as soon thereafter as the Lodge has a regular meeting.

## ARTICLE VI.

### Powers and Duties of the Trustees.

Section 1. In addition to the general duties provided in the Constitution the Trustees shall have charge, control, and general supervision of the grounds and buildings owned by this Lodge, and shall have charge of the leasing and renting of the same upon the terms most advantageous to the Lodge. They shall cause all rentals to be paid promptly to the Secretary; and shall put and keep the grounds and buildings in good condition and repair, and properly protect them from injury or damage of any kind. It shall be their duty to supervise the Steward in the discharge of his duties; to see that the heating, lighting, ventilating, and cleaning of the building and rooms are properly, safely, and economically done; and that tenants comply with the terms of their leases in the care and preservation of the rooms or parts of the building in their pos-

session or use. They may make all reasonable expenditure for the purposes aforesaid; but they shall not incur any cost for extraordinary repairs or improvements, nor execute leases, unless first authorized by the Lodge; and they shall cause all taxes to be paid promptly, and the building to be kept constantly insured.

Section 2. Reports. They shall report to the Lodge the condition of the real estate owned by the Lodge, whenever required to do so by the Lodge; how and by whom occupied; the amount of rent received; by whom and to whom paid; expenses incurred and paid; how and for what purpose; and for anything else deemed pertinent by it, or especially required by the Lodge at any time.

Section 3. They shall receive as compensation for said services the following amounts: Chairman of the Trustees thirty five (\$35) dollars per annum, and each of the other two members twenty (\$20) dollars per annum, said salary to be paid on the last meeting night of December.

## ARTICLE VII.

### Election on Official Certificate or Visiting Card.

Section 1. A Brother making application for membership by transfer, in this Lodge on Official Certificate or Visiting Card, said application shall be referred in the same



manner as provided in Section 7, Article 2 of the Constitution. The Committee shall report at the next regular meeting, or as soon thereafter as practicable, when a ballot shall be taken, and if not more than two black balls appear against him, he shall be declared elected. If three or more black balls appear against him he shall be declared rejected.

## ARTICLE VIII.

### Fees.

Section 1. The Initiation fee for an applicant under 35 years of age shall be Five (\$5) dollars; for an applicant 35 years of age and under 40, seven and 50-100 (\$7.50) dollars; for an applicant 40 years of age and under 45, ten (\$10.00) dollars; for an applicant 45 years of age and under 50, twelve and 50-100 (\$12.50) dollars, and five (\$5) dollars additional for each year the applicant is over 50 years of age.

Section 2. The fee for advancing a degree shall be the same as charged the member applying for admission.

Section 3. For all applicants under 35 years of age the fee for admission into this Lodge of "Ancient Odd Fellows" shall be five (\$5) dollars; for admission by Withdrawal Card five (\$5) dollars; for admission by Dismissal Certificate five and 20-100 (\$5.20) dollars. If such applicant be over 35 years of age and under 50, five (\$5) dol-

lars shall be added to such fee for each period of five years that the age of the applicant exceeds 35 years, and if the applicant be over 50 years of age, five (\$5) dollars shall be added for each year his age exceeds 50.

Section 4. Applicants may be admitted to NON-BENEFICIAL membership in this Lodge, and shall pay a fee of five (\$5) dollars.

Section 5. Such NON-BENEFICIAL members shall pay five cents per week as dues, and shall not be liable to the payment of other dues or assessments.

Section 6. Such NON-BENEFICIAL members shall not be entitled to any pecuniary benefits of any kind from the Lodge.

Section 7. DROPPED MEMBERS. A member who has been dropped for more than one year, may be reinstated upon the payment of one year's dues and all assessments charged to any one Brother during the year preceding that in which application for reinstatement is made; and in addition shall pay the sum charged an applicant for the Initiatory Degree at the age then attained by the Brother making application for such reinstatement. Such application shall be considered and treated in all respects as an application for membership by Initiation.

**ARTICLE IX.****Dues.**

Section 1. Each member of this Lodge from the time of his Initiation shall pay into the general fund the sum of ten cents per week, or one dollar and thirty cents per quarter.

Section 2. All monies paid to this Lodge at any time other than at regular meetings shall be credited by the Secretary as of the date of such payment.

**ARTICLE X.****Sick and Funeral Benefits.**

Section 1. Any Brother in good standing who has attained the third degree, if sick or accidentally injured so as to be unable to pursue his ordinary vocation or some other whereby he may obtain a livelihood, and who at the time he is taken sick, injured, or disabled, is not indebted to the Lodge for more than thirteen weeks dues, shall be entitled to receive from the funds of the Lodge the sum of six dollars (\$6) per week for the first thirteen weeks, and four dollars (\$4) per week for the remainder of his disability, provided that no benefits shall be paid for the first week's disability.

Section 2. The funeral benefits of a brother who has attained the third degree shall be two hundred dollars (\$200). The

funeral benefits of a brother who has not attained the third degree shall be fifty dollars (\$50).

Section 3. In case a brother of the third degree, in good standing, shall lose his wife by death he shall be entitled to receive a funeral benefit of one hundred dollars (\$100).

Section 4. Payments shall be subject to the General Laws of the Order. If a brother dies without having any one dependent on him, or dependent on any one, possessed of sufficient funds to defray funeral expense there shall not be any money drawn from the treasury for said brother's funeral expense.

## ARTICLE XI.

### Nursing and Visiting the Sick.

Section 1. Should it be necessary for the Noble Grand to visit a sick brother who lives at a distance from the Lodge, he or any brother whom he may depute, may hire a conveyance at the expense of the Lodge, the same to be paid from the Contingent Fund.

Section 2. Whenever a brother in good standing shall become sick or disabled and shall need a nurse, it shall be the duty of the Noble Grand and Secretary to employ a suitable nurse by contracting to pay as compensation for such nurse not more than Fourteen (\$14) dollars per week, unless by special order of the Lodge, to take care of such brother as long as a nurse is neces-

sary; the compensation of said nurse shall be a charge against the General Funds of the Lodge, and shall be audited and paid as other charges are paid. Provided, that no member of a brother's immediate family shall be paid for any services rendered in nursing a sick or disabled brother. And provided, further, that this nurse service shall not be continued longer than six weeks, unless by special order of the Lodge, and then only by a two-thirds majority vote of the members present.

## ARTICLE XII.

### Beneficent Donations.

Section 1. No donations of the funds of this Lodge shall be made for any purpose, unless by two-thirds vote of the members present and voting at a regular meeting of the Lodge.

## ARTICLE XIII.

### Widows and Orphans Fund.

Section 1. Five (5) percent of all money received by this Lodge as rent shall be placed in a separate fund, to be known as the Widows and Orphans Fund; said fund to be used at the discretion of the Widows and Orphans Committee, for the relief of Widows or Orphans of deceased Odd Fellows.

Section 2. The Widows and Orphans Committee shall consist of three Past

Grands, one of whom shall be elected annually at the December election and serve for a period of three years. A majority of the Committee shall have authority to draw orders on the Widows and Orphans Fund, for such sums as in their opinion may be necessary to relieve the distress of any widow or orphan of a deceased Odd Fellow.

#### **ARTICLE XIV.**

##### **Construction of By-Laws.**

Section 1. Whenever the words "member" or "brother" are used in these By-Laws, they shall be taken and construed to mean BENEFICIAL member or brother; unless such words are immediately preceded by the words "NON-BENEFICIAL", or unless the contrary intent clearly appears from the text.

#### **ARTICLE XV.**

##### **Amendments.**

Section 1. Any alterations or amendments to these By-Laws, not inconsistent with the General Laws of the Order, may be proposed in writing at any stated meeting of the Lodge and acted upon at the next succeeding meeting.

#### **ARTICLE XVI.**

Section 1. The rules contained in Robert's Revised Rule of Order shall govern this Lodge in all cases to which they are applicable, and in which they are not incon-

sistent with the foregoing By-Laws, the Constitution governing Subordinate Lodges, the Charges, and the General Laws of the Order; all of which are hereby made a part of these By-Laws, and all other By-Laws not contained herein are hereby repealed.
