

Preamble.

Resolution offered to the Alumnæ of the Lewisburg Female Institute May 27th, 1898, by Miss Janie S. Price, and adopted by them at the same meeting:

WHEREAS, The experience of other institutions demonstrates the value and importance of organizing the influence wielded by the old students; and, whereas, such organizations are not only powerful adjuncts in developing and promoting the best interests of the Alma Mater, but also furnish a means of perpetuating and strengthening the friendships formed during school days; therefore, be it

Resolved, That we, the old students of the "L. F. I.," proceed to the organization of such an Association, to be known as the ALUMNÆ ASSOCIATION OF THE LEWISBURG FEMALE INSTITUTE

Constitution.

ARTICLE I.- NAME.

This Association shall be known as the Alumnæ Association of the Lewisburg Female Institute.

ARTICLE II.-GENERAL OBJECT.

The general object and purpose of this Association shall be the promotion of the best interests of our old Alma Mater and the perpetuation of the friendships formed during our school days.

ARTICLE III.-OFFICERS.

The officers of this Association shall consist of a President, five Vice-Presidents, and a Secretary and Treasurer.

ARTICLE IV.—TIME AND PLACE OF MEETING.

This Association shall meet annually in the Society Hall of the "L. F. I." on the Friday preceding the Baccalaureate Sunday of Commencement.

ARTICLE V.

The officers of this Association shall be ex officio members of all Committees.

By-Laws.

I.-ELECTION OF OFFICERS.

The officers of this Association shall be elected annually at the regular meeting during Commencement.

II.-QUORUM.

Seven members of this Association shall constitute a quorum, provided not more than five of the seven live in the same county.

III.-CALL MEETINGS.

In addition to the regular meetings provided for in the Constitution this Association shall meet at any time at the call of the President, said call to be issued only on the application of at least seven members of the Association, representing at least three different counties, and ten days' notice being given prior to date of call meeting.

IV.—CHANGES IN CONSTITUTION.

Changes can be made in the Constitution only by a three-fourths vote of all the members present at any regular meeting.

V.-FEES AND ANNUAL DUES.

An initiation fee of fifty cents shall be charged on entering this Association, and an annual fee of twenty-five cents thereafter.

VI.—COMMITTEES.

The President shall appoint at each regular meeting a Committee of Arrangements to prepare for the reception and entertainment of the visiting Alumnæ during Commencement, and also a Committee on Transportation to see that conveyances are provided for the Alumnæ to and from Ronceverte. The two committees to act jointly as circumstances may require.
